If you are considering coaching in the upcoming season, please complete this form and the Vermont Release Form* and return to the GBGSL Administrator by the following dates:

- No later than July 31ST to be eligible to coach for the fall
- No later than April 1st to be eligible to coach for the spring

As a member of the Vermont Soccer Association, GBGSL is required to have all coaches complete the Vermont Release Form, please note: the Vermont Release Form must be notarized.

These forms will be kept on file and the league will obtain a new criminal record check each time you request to coach. Annual forms are no longer required by the State.

Coaches will not be allowed to coach if these forms are not handed in! You will receive a phone call from a GBGSL Board member advising you that you are suspended from practicing/coaching until the forms are received.
